APPLICATION FOR EQUITATION AND LANGUAGE SUMMER CAMP

GENERAL CONDITIONS

1. Fill in the inscription form and send it by email to <u>info@pirineoecuestre.com</u>, along with the bank transfer receipt for 400 euros per week as a deposit. Please put the student's full name on the receipt.

This deposit shall be refunded in full should the inscription not be accepted.

- 2. Places can be applied for up until the week prior to the desired start date. Given that there are limited places available, orders will be accepted on a first come, first served basis.
- 3. The final payment for the course should be paid in full 30 days before it commences.
- 4. Cancellation or absenteeism on the first day of the course entails that 100% of the course will not be refunded. Cancellation in the 30 and 15 days leading up to the course entails that 70% will not be refunded. Cancellation in the 15 days leading up to the course entails that 90% of the course will not be refunded. In the unlikely event that the centre cancels the course, the participant has the right to a full refund of what has been thus far paid. The deposit paid shall be repaid so long as the cancellation is transmitted 30 days before the start of the selected course. The centre will retain 60 euros as paperwork costs. Once begun, should the participant leave the course, payment shall not be reimbursed.
- 5. Travel: Should the participant avail of the transfer to and from the camp, they must provide all information pertaining to their journey as soon as possible. These transfers have an additional cost depending on distance. A Member of our staff will meet the participant(s) at the agreed upon collection point, and accompany them to the equitation centre. The journey up until the collection point, (or the equitation centre, should they so prefer), shall run at cost to the participant.
- 6. Insurance: Pirineo Ecuestre has an accident insurance and liability insurance policy for all participants. Students should bring their European medical card or private insurance for any incident not related to camp activities.
- 7. Included in the cost of the course is the accommodation, 4 well rounded daily meals, camp activities and insurance for each participant.
- 8. Residence rules are as follows: Participant agrees to adhere to the following norms. Behave correctly and show good manners to fellow participants and all camp personnel at all times. Have a positive attitude and get involved as much as possible. Follow the instructions of staff at all times. Punctuality is key. Respect meal times and break times. Under no circumstances are participants permitted to leave the camp grounds. Smoking or drinking alcohol is strictly prohibited. Use of any electronics such as mobile phone, tablets, iPads etc is restricted to half an hour daily. Should these rules be broken staff members will be informed immediately. As a last resort after repeated infractions of the rules the participant shall be returned home, running at cost to the participant. This includes any compensation for damages and damages to third person parties.
- 9. Pirineo Ecuestre S.L. is not responsible for lost items or money.
- 10. Acceptance of the rules and conditions: Inscription to the course implies an understanding and complete acceptance of the general conditions. Any grievances or issues in regard to the interpretation of this contract may be dealt with in the Spanish Court of Law.
